

Official Rules
2018 Dodge Challenger R/T Giveaway
Saturday, July 21, 2018

A. Participant Eligibility:

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Entrants must be a Carter Club member; membership is free.
- iii. Entrants must be on premises at the drawing time during this promotion to win.
- iv. Entrants must have earned points, redeemed points, or requested a free entry into this promotion.
- v. Persons who are on PCCH's list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

B. Agreement to Official Rules:

- i. By Participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

C. Promotion Period:

- i. The promotion period starts Sunday, June 10, 2018 at 7:01 a.m. Central Time (CT),
- ii. The promotion ends at 11:00 p.m. CT on Saturday, July 21, 2018.
- iii. PCCH's computer is the official time-keeping device for this promotion.

D. How To Enter: Eligible guests may enter to participate in the drawings in the following ways:

- i. By using your Carter Club card, you will earn ten (10) entries for every 250 same-day base points earned or 250 points redeemed. Simply present your Carter Club card to the Carter Club booth, open every day starting at 7:00 am. During the hours of operation, entries may be obtained in the Eagle Lounge for Eagles and Golden Eagles.
- ii. Table Games players will receive ten (10) bonus entries for every hour of consecutive play from Sunday, June 10, 2018 to Thursday, July 19, 2018.
- iii. Bingo Players will receive ten (10) bonus entries for every purchase of an early bird package from Sunday, June 10, 2018 to Thursday, July 19, 2018.
- iv. Ten (10) free entries will be given to new Carter Club members on the day they open the account.
- v. Entry multipliers will be available for on June 13, 20, & 27, 2018 and July 4, 7, 8, 15, & 20, 2018. **(July 4th will be a special multiplier date. All tier levels will receive 5X the entries for every 250 points earned or redeemed that day.)**
 1. Golden Eagles will receive 6X entries,
 2. Eagles will receive 5X entries,
 3. Thunderbirds will receive 3X entries
 4. Loon, Crane and Carter Club members 2X entries
 5. Additional entry multipliers may be offered through a mailer or the mobile app to qualified guests.
- vi. **PCCH will not honor damaged, late, illegible, incomplete, or copied entries. Entries free or earned are considered property of Potawatomi Carter Casino Hotel. Entries leaving the building will be considered void. Carter Club members who have taken entries out of the building may have all of their entries voided if it cannot be specifically determined which entries were taken outside of the building.**

E. Free Entry:

- i. No purchase necessary; purchase will not increase your chances of winning. Void where prohibited. Any Carter Club member may attain one (1) free entry in the drawing by sending a written request with name of the specific promotion and date, guest's full name, complete address including zip code (no P.O. boxes), daytime phone number with area code, and date of birth, in a self-addressed stamped envelope to: Giveaway, Potawatomi Carter Casino Hotel, 618 State Highway 32, Wabeno, WI 54566. Free entry requests received by PCCH prior to the commencement of the promotion period, or after 12:00 p.m. CT on July 19, 2018 will be void.

F. Prizes:

- i. Prizes are: One (1) 2018 Dodge Challenger R/T – valued at \$36,998, twelve (12) \$500 cash prizes, and four (4) \$2,000 consolation prizes.
 1. Total value of this promotion is \$50,998. Vehicle winner will have the opportunity to accept a cash option in the amount of \$29,598.04.
 2. If the vehicle winner selects the cash option the night of the giveaway, winner will be awarded a cash amount of \$3,000 that night. A check for the remaining \$26,598.04 will be sent to them following the promotion.
- ii. Total value of this promotion is \$50,998 should the winner select the car.
- iii. **A variance will occur should the winner select the cash option. Total of promotion with cash option will be \$43,598.04 causing a variance of \$7,399.96.**
- iv. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is". PCCH expressly disclaims all representations and warranties with respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.
- v. All necessary tax documents must be completed before prize is awarded.

G. Drawing and Notification:

- i. Seventeen (17) winners will be selected for this promotion. Two (2) names will be drawn from the bin each hour between 5:00 pm and 10:00 pm to win \$500 cash. At 11:00 pm, five (5) names will be drawn to go up on stage. Four (4) will win a consolation prize of \$2,000 each and one (1) will win the car. Winning entry will be drawn from the bin and taken to the Carter Club booth for verification.
- ii. **Drawings: Entries will be issued until ten (10) minutes prior to the posted ending time of the promotion, (10:50 pm) on Saturday, July 21, 2018. All entries must be in the bin one (1) minute prior to the posted ending time of the promotion, (10:59 pm) on Saturday, July 21, 2018.**
- iii. Odds of winning will be determined by the number of entries in the bin at the time of the drawing.
- iv. A Marketing team member will verify the selected winner meets the criteria of the drawing before the name is announced over the PA system.
- v. Winners must be present at the time of the drawing.
- vi. Winners will have five (5) minutes to make their presence known at the VIP booth to claim their prize or the entry will be voided and a new winner will be drawn.
- vii. There is a limit of two (2) wins per person for the drawings between 5:00 pm and 10:00 pm. After winning guests have reached the win limit, entries drawn with their names on them will be put back into the bin for the 11:00 pm drawings. There is an additional one (1) win per person for the 11:00 pm drawings. Total of three (3) possible wins per person.
- viii. Drawing bin will remain closed until selected winner has been verified.
- ix. **Management has the right to alter or cancel a promotion at any time.**

H. Prize Acceptance/Restrictions:

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- v. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

I. Release/Publicity/Use of Personal Information:

- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

J. General Conditions:

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the Spirit of these Official Rules.
 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

K. Limitations of Liability and Release.

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the promotion.
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize.
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
