



**Official Rules
Lip Sync Showdown
Saturday, August 18, 2018**

A. Participant Eligibility:

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Entrants must be a Carter Club member; membership is free.
- iii. Entrants must be on premises during the contest to win.
- iv. Entrants must have registered before registration period ends to be eligible to participate in this event.
- v. Persons who are on PCCH's list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

B. Agreement to Official Rules:

- i. By participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

C. Promotion Period:

- i. The promotion period starts Saturday, August 18, 2018 at 4:00 p.m. Central Time (CT),
- ii. The promotion ends at 7:00 p.m. CT on Saturday, August 18, 2018
- iii. PCCH's computer is the official time-keeping device for this promotion.

D. How To Enter: Eligible guests may enter to participate in the Lip Sync Showdown in the following ways:

- i. Contestants can register solo or group act at the Carter Club booth by August 6, 2018. All members of the group/act must be included on the registration form.
- ii. Download a registration form from cartercasino.com and submit the form with song choice to the Carter Club by August 6, 2018 - Attn: Stevie Menne – Promotions.
- iii. Registration is open to the first twenty (20) acts to sign up and pay the \$10 cover charge.
- iv. Song choice must be four (4) minutes or less in length. If longer than four (4) minutes, music will fade out.
- v. Songs must be suitable for radio play with no excessive vulgar language or content.
- vi. Contestants will be notified of approval no later than August 10, 2018.
- vii. Contestants must provide their own props. Microphones will be provided.
- viii. Contestants will be allotted two (2) minutes to set up or tear down their props.
- ix. There is a non-refundable \$10 cover charge per person.

F. Prizes:

- i. Prizes are: First place = \$1,000, second place = \$500, & third place = \$200.
- ii. Total of three (3) winners for this promotion.
- iii. Total value of this promotion is \$1,700
- iv. **There may be a variance for this promotion depending on how many acts perform.**
- v. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is". PCCH expressly disclaims all representations and warranties with respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.



- vi. The winners may be required to provide valid picture identification and a Carter Club card to claim prize.
- vii. All necessary tax documents must be completed before prize is awarded.

G. Drawing / Notification:

- i. Each contest participant will be asked to have their photo taken to be used for advertising purposes. If the participant does not want their photo used for advertising purposes, it must be clearly marked on the release form.
- ii. All participants must check in prior to the start of the contest no later than 3:30 pm at Carter Club at the VIP booth. If a group act, all members must check in together.
- iii. Participants entering the contest as a group must select a head person who has a valid Carter Club card. This person will be responsible to represent the group and sign for the prize, should they win.
- iv. Judging will be done by available managers and supervisors. Marketing team members will not do the judging. Every effort will be made to select judges that do not have family or friends participating in the contest.
- v. Judges will use a scoring sheet and will be judged on lip sync ability, stage presence, and creativity. The participants will be ranked in order by point value with the highest points taking first place in the contest. Ties will be broken by the panel of judges with a revote between only the participants that tied. Judges decisions are final!
- vi. At approximately 7:30 pm, the contest winners will be announced and the cash prizes awarded.
- vii. First place winner will receive \$1,000 cash, second place winner will receive \$500 cash, & third place winner will receive \$200 cash. Each guest can only win one (1) place.
- viii. Odds of winning will be determined by the number of participants in the contest.
- ix. A Marketing team member will verify the selected winner meets the criteria of the contest before the name is announced over the PA system.
- x. Winners must be present at the time of the contest.
- xi. Winners will have five (5) minutes to make their presence known at the VIP booth to claim their prize.
- xii. After the five (5) minute time period has expired, if a winner does not come forward, the prize will be awarded to the next winner with the most points.
- xiii. **No masks and/or fake weapons will be allowed. Costumes must be worn in good taste. Offensive costumes will not be permitted to perform. They may re-enter the casino without costume and in regular clothing.**
- xiv. ***Management has the right to alter or cancel a promotion at any time.***

H. Prize Acceptance/Restrictions:

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- v. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

I. Release/Publicity/Use of Personal Information:



- i. Participants will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an advertising release form must be filled out.

J. General Conditions:

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
 - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the Spirit of these Official Rules.
 - 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

K. Limitations of Liability and Release.

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the Promotion.
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize.
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
