



**Official Rules  
Blackjack Tournaments  
Tuesdays in September, 2018**

**A. Participant Eligibility:**

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Entrants must be a Carter Club member; membership is free.
- iii. Entrants must be on premises during this promotion to win.
- iv. Entrants must have earned points from slot or table game play or have accrued one (1) hour of consecutive play **from table game play**, to receive an entry into this promotion.
- v. Persons who are on PCCH's list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

**B. Agreement to Official Rules:**

- i. By participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

**C. Promotion Period:**

- i. The promotion period starts Tuesday, September 4, 2018 at 7:01am Central Time (CT),
- ii. The promotion ends at 10:00 pm CT on Tuesday, September 25, 2018.
- iii. PCCH's computer is the official time-keeping device for this promotion.

**D. How To Enter:** Eligible guests may enter to participate in the tournament in the following ways:

- i. By using their Carter Club card, Carter Club members must earn an accumulated total of 500 points by playing slots or table games, from Thursday through Tuesday starting the week previous to the tournament date, to be eligible for one (1) seat in the tournament, each day of the promotion. Simply present their Carter Club card to the Carter Club booth, open every day starting at 7:00 am. Must register at the Carter Club. – **OR** -
- ii. One (1) hour of consecutive play at the tables equals one (1) seat in the tournament. Participants will receive a certificate at the tables for each consecutive hour of table game play, Thursday through Tuesday starting the week previous to the tournament, to be redeemed at the Carter Club the day of the tournament.
- iii. Must register at the Carter Club by 5:00 pm to be eligible each day of the tournament. Tournament will start at 6:00 pm each tournament date.
- iv. Must have a minimum of ten (10) participants to run the tournament.
- v. **PCCH will not honor damaged, late, illegible, incomplete, or copied entries. Entries free or earned are considered property of Potawatomi Carter Casino Hotel. Entries leaving the building will be considered void. Carter Club members who have taken entries out of the building may have all of their entries voided if it cannot be specifically determined which entries were taken outside of the building.**

**E. Free Entry:**

- i. No purchase necessary; purchase will not increase your chances of winning. Void where prohibited. Any Carter Club member may attain one (1) free entry in the tournament by sending a written request with name of the specific promotion and date, guest's full name, complete address including zip code (no P.O. boxes), daytime phone number with area code, and date of birth, in a self-addressed stamped envelope to: Tournament, Potawatomi Carter Casino Hotel, 618 State Highway 32, Wabeno, WI 54566. Free entry requests received by PCCH prior to the



commencement of the promotion period, or after 12:00 pm CT on September 23, 2018 will be void.

**F. Prizes:**

- i. Prizes are: one (1) 1<sup>st</sup> place - \$500, one (1) 2<sup>nd</sup> place - \$300, & one (1) 3<sup>rd</sup> place - \$100 each week.
- ii. Total match play prizes based on a full field of 36 players. If full field, three (3) qualifying rounds will be played with top two (2) chip holders from each table receiving \$20 each in match play chips. Maximum total of match play for each tournament date: \$280. Maximum total match play for the month: \$1,920.
- iii. Maximum total value of this promotion **\$3,600 in cash and \$1,920 in match play = \$5,520 total.**
- iv. **There may be a variance for this promotion.** Variance due to lower number of participants per tournament.
- v. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is". PCCH expressly disclaims all representations and warranties with respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.
- vi. The winners may be required to provide valid picture identification and a Carter Club card to claim prize.
- vii. All necessary tax documents must be completed before prize is awarded.

**G. Drawing and Notification:**

- i. Tournament dates are: Tuesday, September 4, 11, 18, & 25, 2018. The day of the tournament(s), players will have one (1) entry form filled out and put into a bin for each certificate of consecutive play earned during the qualifying period previous to the tournament and/or one (1) entry form for each additional 500 points earned during the qualifying period the week previous to the tournament. In the event the player is eliminated in the first round and there are slots available in the subsequent rounds, names will be drawn as a wildcard drawing to fill the open slots in the tournament.
- ii. Players must register at the Carter Club each tournament date between 7:01 am and 5:00 pm.
- iii. Players will be randomly assigned a seat in the tournament upon registration at the VIP booth.
- iv. Players name, Carter Club number, and table assignment will be announce over the PA ten (10) minutes prior to the start of the round.
- v. Players must be in their assigned seats five (5) minutes prior to the start of round of play.
- vi. Number of rounds played will be determined by the number of participants that register for the tournament. Full field is thirty-six (36) players.
- vii. Each player will receive \$500 of tournament chips at the beginning of each round.
- viii. Players may only play one hand.
- ix. Each round will consist of twenty-one (21) hands.
- x. Dealer button (marker to determine who is dealt to first at the start of a new hand) shall rotate in a clockwise manner per the dealers view point, each hand.
- xi. Players will have thirty (30) seconds to place their bet. Players that do not place their bet within the allotted time, the minimum will be wagered.
- xii. Once a wager is made, it cannot be changed.
- xiii. Players will have thirty (30) seconds to make their play decisions. If play decision is not made in the allotted time, player will be passed.
- xiv. Player wagers must be in full view at all times.
- xv. A chip count will be done after the seventeenth (17<sup>th</sup>) hand.
- xvi. Players must place wagers in order beginning with hand seventeen (17).
- xvii. Players must not hold conversations or be coached in any way during tournament play. **Collusion among players is prohibited and will result in disqualification.**
- xviii. If a round does not have enough players to fill a table, a wild card drawing from those who have been eliminated can be done to fill the open seats in that round.
- xix. Winning bankrolls do not roll over to next round.



- xx. In the event of a tie, there will be five (5) additional hands dealt to those involved in the tie.
- xxi. At the end of the tournament, the top six (6) players with the highest chip count from the qualifier rounds will advance to the final round.
- xxii. Top two (2) highest chip holders from each session from each of the qualifying rounds will receive \$20 in match play chips to be redeemed the day of the tournament.
- xxiii. Top three (3) finishers from the final round will receive a cash prize according to rank they placed. 1<sup>st</sup> place - \$500, 2<sup>nd</sup> place - \$300, & 3<sup>rd</sup> place - \$100.
- xxiv. ***Management has the right to alter or cancel a promotion at any time.***

**H. Prize Acceptance/Restrictions:**

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable.
- v. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

**I. Release/Publicity/Use of Personal Information:**

- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

**J. General Conditions:**

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
  - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the spirit of these Official Rules.
  - 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

**K. Limitations of Liability and Release.**

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the promotion
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays



- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages
