



**Official Rules
Club 50
Wednesdays in January 2023**

A. Participant Eligibility:

- i. Promotion is open to U.S. residents who are 50 years of age or older at the time of entry.
- ii. Entrants must be a Northwoods Club member; membership is free.
- iii. Entrants must be on premises during this promotion to win.
- iv. Entrants must have earned points to participate in this promotion.
- v. Persons who are on PCCH's list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

B. Agreement to Official Rules:

- i. By Participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

C. Promotion Period:

- i. The promotion period starts Wednesday, January 4, 2023 at 11:00 am Central Time (CT),
- ii. The promotion ends at 7:00 pm CT on Wednesday, January 25, 2023.
- iii. PCCH's computer is the official time-keeping device for this promotion.

D. How To Enter: Eligible guests may enter to participate in the promotion in the following ways:

- i. By using their Northwoods Club card, club members 50 years in age or higher can earn 250 same day base points to receive one of the following options:
- ii. **1.) one (1) \$10 Gas voucher and \$10 in Potawatomi Play OR 2.) \$20 in Potawatomi Play Gas vouchers are valid for seven (7) days from date printed.**
(EX: Print date: 10/1/2021 – Expiration date: 10/8/2021.)
Potawatomi Play is to be used the day the points are earned.
- iii. Eligible club members must earn 20 same day points and be 50 years of age or higher to participate in the random drawings.

E. Free Entry:

- i. No purchase necessary; purchase will not increase your chances of winning. Void where prohibited. Any Northwoods Club member may attain one (1) free entry in the drawing by sending a written request with name of the specific promotion and date, guest's full name, complete address including zip code (no P.O. boxes), daytime phone number with area code, and date of birth, in a self-addressed stamped envelope to: Giveaway, Potawatomi Carter Casino Hotel, 618 State Highway 32, Wabeno, WI 54566. Free entry requests received by PCCH prior to the commencement of the promotion period, or after 12:00 p.m. CT on January 23, 2023 will be void.

F. Prizes:

- i. **Earn & Get Prizes:** one (1) \$10 gas voucher and \$10 Potawatomi Play **OR** one (1) \$20 Potawatomi Play.
- ii. **Random drawing prizes:** (8) \$50 Potawatomi Play
- iii. Total estimated value of this promotion is \$8,800 (\$2,200 per date)

- iv. **There may be a variance as the number of participants is estimated for this promotion.** The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is”. PCCH expressly disclaims all representations and warranties with respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.
 - v. The winners may be required to provide a non-expired, government issued photo identification and a Northwoods Club card to claim prize.
 - vi. All necessary tax documents must be completed before prize is awarded.
- G. Drawing and Notification:**
- i. Limit of one (1) win per person per date of promotion for the drawings. Promotion dates are: January 4, 11, 18, & 25, 2023.
 - ii. **Earn & Get prizes:** \$10 Potawatomi Play & \$10 Gas **OR** \$20 Potawatomi Play
 - iii. One (1) winner will be randomly drawn each hour from noon to 7:00 pm to each win \$50 Potawatomi Play. **Total of eight (8) \$50 Potawatomi Play drawing winners per date.**
 - iv. **Drawings: Random drawings generated through CMP.**
 - v. Odds of winning will be determined by the number of guests who meet the point requirements to be eligible at the time of the drawing.
 - vi. A Marketing team member will verify the selected winner meets the criteria of the drawing before the name is announced over the PA system.
 - vii. Winners must be present at the time of the drawing.
 - viii. Winners will have five (5) minutes to make their presence known at the VIP booth to claim their prize or the entry will be void and a new winner will be drawn.
 - ix. One winner will be randomly drawn through CMP each hour from noon to 7:00 pm each Wednesday in January 2023.
 - x. Winners will each receive a \$50 Potawatomi Play prize.
 - xi. Limit of one (1) win per person per drawing date.
 - xii. **Management has the right to alter or cancel a promotion at any time.**
- H. Prize Acceptance/Restrictions:**
- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
 - ii. The winners will be required to provide non-expired, government issued photo identification and a Northwoods Club card to claim prize.
 - iii. Prizes are not transferrable or assignable.
 - iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable.
 - v. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.
- I. Release/Publicity/Use of Personal Information:**
- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.
- J. General Conditions:**
- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
 - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the spirit of these Official Rules.

2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
 - iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
 - iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.
- K. Limitations of Liability and Release.**
- Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:
- i. Unauthorized human intervention in the promotion
 - ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
 - iii. Printing errors
 - iv. Errors in the administration of the promotion or the processing of registrations and game plays
 - v. Late, lost or undeliverable mail
 - vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize
 - vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages
