

**Official Rules**  
**“Pump Perks” (Earn & Redeem)**  
**Everyday (Revised)**

**A. Participant Eligibility:**

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Participants must be a Northwoods Club member; membership is free.
- iii. Participants must be on premises and earned & redeemed required points to be eligible to participate in the promotion.
- iv. Persons who are on PCHC’s list of banned patrons are not eligible to enter.
- v. Employees of PCHC, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCHC Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

**B. Agreement to Official Rules:**

- i. By participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCHC, which are final and binding in all matters related to the promotion.

**C. Promotion Period:**

- i. The promotion period is January 1, 2022 at 7:00 am Central Time (CT)
- ii. The promotion end date TBD.
- iii. PCHC’s computer is the official time-keeping device for this promotion.

**D. How To Enter:** Eligible guests may participate in the promotion in the following way:

- i. Eligible Northwoods Club members can earn and redeem 250 points to receive a \$5 voucher, earn and redeem 500 points to receive a \$10 voucher, earn and redeem 750 points to receive a \$15 voucher, earn and redeem 2,250 points to receive a \$45 voucher, or earn & redeem 3,750 points to receive a \$75 voucher.

**E. Free Entry:**

- i. No free entry as this is a point redemption program.

**F. Prizes:**

- i. \$5 voucher, \$10 voucher, \$15 voucher, \$45 voucher, or \$75 voucher based on points earned & redeemed within a two-day consecutive period.
- ii. Gas vouchers must be redeemed at the Guest Service booth before the booth closes on the second day of earning the required points. EX: Day 1, January 1, 2022 – play all day and/or through the night. Day 2, January 2, 2022 – play during the day, redeem cumulative earned points from both days for up to four (4) gas vouchers – maximum of (four (4) vouchers per person for the two-day period). After the Guest Service booth is closed, Sweetgrass tier members may receive their gas vouchers in the Eagle Lounge during lounge hours.

- iii. Recipients of vouchers are responsible for any applicable taxes or fees. Items are not redeemable for cash.
- iv. Gift Cards cannot be purchased with vouchers.
- v. The guest will be required to provide non-expired, government issued photo identification and a Northwoods Club card to claim voucher.

**G. Rules & Notification:**

- i. There is a limit of four (4) vouchers per person per two-day earning period, any combination. EX: 4 - \$15, or 2 - \$25 & 2 - \$75, etc.
- ii. Vouchers can be issued for a consecutive two-day point earning & redeeming period. Vouchers must be redeemed before the Guest Services booth closes on the second day. During Guest Service booth hours of operation. Sweetgrass tier members may also receive their gas vouchers in the Eagle Lounge during lounge hours of operation.
- iii. Vouchers are to be used for fuel for personal vehicles or C-store purchases only.
- iv. Cannot be combined with any other offers or promotions.
- v. Vouchers are valid for seven (7) days from date printed. (EX: Print date: 1/1/2022 – Expiration date: 1/8/2022)
- vi. ***Management has the right to alter or cancel a promotion at any time.***

**H. Prize Acceptance/Restrictions:**

- i. Guests must comply with all terms and conditions of these Official Rules.
- ii. The guest will be required to provide non-expired, government issued photo identification and a Northwoods Club card to claim gas voucher.
- iii. Vouchers are not transferrable or assignable.

**I. Release/Publicity/Use of Personal Information:**

- i. Guests may be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

**J. General Conditions:**

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCHC reserves all rights, in its sole discretion, may:
  - 1. Suspend the promotional event to address the impairment and then resume the promotional event in a manner that best conforms to the spirit of these Official Rules.
  - 2. Cancel the promotional event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCHC reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCHC reserves the right to seek damages from any such person to the fullest extent of the law.

- iv. PCHC's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

**K. Limitations of Liability and Release.**

Entrants agree to release and hold harmless PCHC, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the promotion
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages
