

### **Official Rules**

### Intermission Drawings – October 2022 through September 2023

Sundays, Wednesdays, and Saturdays (excludes sessions listed in C. Promotion Period)

# A. Participant Eligibility:

- i. Promotion is open to those who are 18 years of age or older at the time of entry.
- ii. Entrants must be a Northwoods Club member; membership is free.
- iii. Entrants must be on premises and playing bingo at the drawing time during this promotion to win.
- iv. Entrants must have purchased an entry pack and used their Northwoods Club Card to be entered in the electronic drawing.
- v. Limit one entry per guest per day.
- vi. Person who are on PCCH's list of banned patrons are not eligible to enter.
- vii. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Bingo Department, Planet Bingo Employees, Higgins Bingo Supply Employees, and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

### B. Agreement to Official Rules:

i. By participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

### C. Promotion Period:

- i. Bingo Sessions held on Sundays, Wednesdays, and Saturdays.
- ii. Excludes Black Light Bingo, \$500 Friday, Bashes, Marathon Bingo Sessions, Jackpot Sessions, Good Neighbor Sessions (Thursdays), Bonus Play Sessions (select Fridays).
- D. How To Enter: Eligible guests may enter to participate in the drawings in the following way:
  - i. Northwoods Club Members using their Northwoods Club Card while purchasing an entry pack will automatically receive an electric entry into the Intermission Drawings.
    - Guests can purchase an entry pack from the admissions booth during times of operation:
      - 1. Wednesdays: 4:30pm to 6:45pm
      - 2. Saturdays: 4:30pm to 6:45pm
      - 3. Sundays: 11:30am to 1:45pm

#### E. Prizes:

ii.

- i. All winners will receive \$25 in Bingo Return play.
- ii. One win per player per day.
- iii. Prizes are valid for 30 days from issue no extensions.

## F. Drawing and Notification:

- i. Five winners will be drawn each regular session.
- ii. Electronic drawings will take place after the completion of the Roulette Game.
- iii. Odds of winning will be determined by the number guests playing bingo who have used their Northwoods Club Card at the time of purchase.
- iv. 5 names will be drawn at one time through the Epic Player drawing feature.

- v. A Bingo team member will verify the selected winner meets the criteria of the drawing before the name is announced in the Bingo Hall.
- vi. If selected winner does not meet the criteria, a new winner will be selected.
- vii. Bingo team member will announce the winners in the bingo hall after the completion of the intermission break (after game 14).
- viii. Management has the right to alter or cancel a promotion at any time.

# G. Prize Acceptance/Restrictions:

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. Winners must sign a Prize Control Tracking Sheet before obtaining prize.
- iii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iv. Prizes are not transferrable or assignable.
- v. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- vi. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.
- vii. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is". Noncash prizes are not redeemable for cash. By accepting the prize, winner agrees to abide by any terms, conditions, and restrictions provided by the ticket.
- viii. If needed, the winners will be required to fill out a Promotional Prize Payment form, a W-9 tax form for any cash/trip received and a Contest Prize Release/Publicity Form.

# H. Release/Publicity/Use of Personal Information:

i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

## I. General Conditions:

- In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
  - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the Spirit of these Official Rules.
  - 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.
- v. In the even that a potential winner is disqualified for any reason, time permitting, PCCH will award the applicable prize to an alternate winner in a random drawing from among all remaining eligible entries, alternates will be chosen one at a time until there is a valid winner that meets all of the requirements.



## J. Limitations of Liability and Release.

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the Promotion.
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or In part, from the entrant's participation in the Promotional Event of acceptance or use of any prize.
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
